On the first day there was a workshop/panel discussion on how to meet your local agriculturalists. The panel was made up of a dairy farmer, orchard operator, hydroponic lettuce grower and an Alpaca farm owner. The farmers gave an outline of their farms and conducted a question and answer session.

The lettuce grower was very interesting. He has 5 acres under glass for growing just lettuce. He is planning to expand his business by adding on more greenhouses.

On the second day we toured the Jordan Dairy Farm in Rutland, MA. We toured the dairy facilities and the digester they use to digest their manure and the methane runs a generator that runs the farm. Excess energy is sold to the power company. At the end of the tour we all had ice cream before heading back to the hotel. With the leadership of the Massachusetts State Lecturer Janet Segur, the seven State Lecturers worked together to put on a great program for the three day conference. Unfortunately, it is sad to report that Norwich Grange No. 172 has sold their hall and will be turning in their Charter. This will be the <u>fourth</u> Grange that has closed since I've been your State Master. I hope that the Norwich Grange members will find a new home in a nearby Grange.

Todd, our State Secretary, has sent out the Call to Session for the upcoming State Session from October 17 to 19 in Norwich. It would be great to see each Grange have a delegate at this session. 

### **CT Agricultural Experiment Station**

Committee The Connecticut Agricultural Experiment Station (CAES) is the Connecticut State government's agricultural experiment station, a state government component that engages in scientific research and public outreach in agriculture and related fields. It is the oldest state experiment station in the United States, having been founded in 1875. Its official mission is to "develop, advance, and disseminate scientific knowledge, improve agricultural productivity and environmental quality, protect plants, and enhance human health and well-being through research for the benefit of Connecticut residents and the nation." The station operates a main research campus in New Haven, a research farm in Hamden, a satellite research facility and farm

in Windsor, and a research farm in Griswold.

Continued from page one... Station, Analytical Chemistry, began its work in 1875 testing fertilizer and later sees, animal feed, human foods, drugs and pesticides. This work continues today, and is organized into two categories: food safety and environmental monitoring. The department works with State and Federal agencies to improve pesticide and toxin screening of food sold in Connecticut. The department also has the

capability to test for environmental contaminants and toxins in toys and other consumer products at very low concentrations. They test soils for heavy metals, and are investigating the cycling of organic pollutants in the environment, with an emphasis on phytoremediation issues. Additional investigations on the impact of nanoparticles on agricultural crops and on the potential contamination of the food chain are also being undertaken. Work has also been conducted in collaboration with Biochemistry and Genetics as well as colleagues from the Valley Laboratory to investigate which seed crops are best suited for the production of biodiesel in Connecticut. Recently, the department has been working with the US FDA on the testing of seafood from the Gulf of Mexico for chemical by-products of the Deepwater Horizon oil spill in 2010.



My thanks to everyone who contributed to the gift I received at Lecturer's Conference. Connecticut is a great state, full of wonderful Grangers.

The new format for the conference was well received by those attending. Connecticut had more in attendance than any other state except the home state of Massachusetts. We had a great group and I was told we had the noisiest group on Spirit group. I thank each and every one of you and hope you enjoyed it.

Our part of the program was a fantastic skit written by Nancy Weissmuller entitled "George and Harriet - The Farmer's Wife." Did You Know?

The CAES has studied doezens of crops. The hybrid corn that feeds the world was invented at the Connecticut Agricultural Experiment Station's Lockwood Farm in 1919. Organic fungicides were also developed there, some of which are still in use to combat plant diseases. The Connecticut State Grange has long been a supporter, rising to support the Station each time State budget cuts were threatened.

Featured in the skit was Noel Miller as George and Cheri Robinson as Harriet. At one point people in the audience wished they had rotten tomatoes to throw at Noel and one person threatened him with a baseball bat. but, all ended with a smile as they hugged and made up.

No decision has been made on the conference for 2021 except that we will be meeting in New Hampshire. I have a meeting in Jan. and after that I should have more information.

# **Resolutions for the 135th Annual Sesson**

The following are the resolutions received up to the date of printing of this issue. A list of the Session Committees and their assigned resolutions will be printed in the October issue.

### 1) RE: BANNING OF ROUND-UP PRODUCTS

WHEREAS Round-Up products were intended as an herbicide as a means to control and eliminate invasive species such as poison ivy, and

WHEREAS research has determined that the active ingredient, glyphosate and the inert ingredients of Round-Up are responsible for an alarming increase in illness and death in birds, animals and potentially humans, and

WHEREAS it has been demonstrated that Round-Up kills bees and other insects, and

WHEREAS when in use, the runoff from this herbicide is detrimental to the aquifer and may be toxic to amphibians and fish, and

**WHEREAS** other developed countries in the world have currently been in the process of banning Round-Up products.

THEREFORE BE IT RESOLVED that the national Grange contact a representative of the Environmental Protection Agency and the United States Department of Agriculture to encourage the development of legislation to ban the sale and use of Round-Up products or their chemical equivalents in the United States of America.

#### 2) RE:CT'S"INVISIBLE"RESIDENTS

WHEREAS a recent report by the State of Maine Department of Motor Vehicles states there are more than 1,457 Connecticut residents with vehicles registered in Maine, and

WHEREAS these scofflaws cause millions of dollars in lost property tax revenue to Connecticut's municipalities and, in turn, increased tax burden on the rest of the State's residents, and

WHEREAS towns like Manchester and Colchester invested a great amount of time and money tracking down, valuing and listing vehicles owned by these "invisible" residents one by one, and

**WHEREAS** communication between the Connecticut DMV and their counterparts in other states is severely lacking, and

WHEREAS improved communication and shared information between the six New England states and New York along would go a long way towards improving this situation along with enforcement of the rarely enforced \$1,000 fine for failure to register vehicles in the State of Connecticut within 60 days.

THEREFOREBEITRESOLVED the Connecticut StateGrange go on record encouraging theState of Connecticut Department ofMotor Vehicles to work with the fiveother New England states and NewYork to improve communication andinformation sharing between thestates to improve compliance withstate law, and

**BE IT FURTHER RESOLVED** the \$1,000 fine for failure to register vehicles in the State of Connecticut within 60 days of taking residence be strictly enforced.

#### 3) RE: OVERHAUL OF CONN. DMV

WHEREAS fees charged by the Connecticut Department of Motor Vehicles are well above the nationwide average in nearly every category, and

**WHEREAS** Connecticut's residents continue to pay a premium for DMV services while receiving substandard service and wait times

at offices that can exceed two hours, and

WHEREAS failures in DMV systems have resulted in (but are not limited to) thousands of residents driving on expired registrations because of failures in DMV notification systems, and

WHEREAS the State of Connecticut is considering reintroducing tolls to increase revenue at a time when the DMV is losing revenue through its inability to track out of state registration and license scofflaws, and

WHEREAS Governor Lamont's proposed solution to the problem is to extend driver's license renewals from six to eight years and registrations from two to three years, and

WHEREAS these proposals may reduce public interactions with the DMV, but they certainly do not correct the tremendous problems with this agency which includes a computer system that's been plagued with problems since its installation and other computer systems used by the agency that are simply out of date, and

WHEREAS Connecticut taxpayers should demand better service, modern systems and a higher level of accountability from the DMV rather than excuses and quick fixes.

THEREFOREBEITRESOLVEDtheConnecticutStateGrangeurgetheAssembly to demand changesand/or pass legislation overhaulingtheConnecticutDepartmentofMotorVehiclesfromthegroundupwithmoderncomputersystems,greateraccountabilityandlevel of customerservicethat iscommensuratewiththefeescharged.

### 4) RE: ELIMINATION OF STYROFOAM/POLYSTYRENE

WHEREAS Styrofoam is the DOW Chemical trade name for expanded polystyrene plastic ...continued next page manufactured in the United States since 1947, and

WHEREAS expanded polystyrene is used in a wide array of products like building insulation, crafting materials, floral arrangements and food packaging, and

WHEREAS nearly 2.5 million drinking cups made from expanded polystyrene are used in the United States each year, and

**WHEREAS** nearly 30% of all landfill space is consumed by polystyrene, and

WHEREAS polystyrene recycling is extremely limited because it can only be re-purposed into itself or a very similar material, and

WHEREAS it is believed that it can take up to 500 years for polystyrene to break down, but only if exposed to sunlight, and

WHEREAS the cost of biodegradable replacements for polystyrene based products continue to be very expensive due, in part, to the widespread availability of inexpensive polystyrene products, and

**WHEREAS** Connecticut recently enacted laws limiting the use of plastic shopping bags, and

WHEREAS the use of polystyrene is just as environmentally irresponsible as the use of plastic bags, and

WHEREAS the elimination of single-serve food containers containing expanded polystyrene would be a great step towards improving our environment.

THEREFOREBEITRESOLVEDtheConnecticutStateGrangeurgetheConnecticutGeneral Assembly to pass legislationeliminatingtheuseofsingle-serveexpandedpolystyrene(Styrofoam)foodpackaginginthisstate.

### 5) GUN-FREE GRANGE MEETING & EVENT VENUES

WHEREAS Grange meetings and events are held in a variety of venues, but not limited to, e.g.: a dedicated Grange Hall, a public space such as a library, church hall, school, community center, restaurant or catering hall, public or private park, or even a private residence, and

WHERAS certain law enforcement officials are required to carry a permitted gun, concealed or visible, on their person at all times, and

WHEREAS in the Ritual for opening the Subordinate/Community Grange meeting, the Gatekeeper's declaration "I therefore close this Outer Gate in Faith, in Hope and Charity and will guard it with Fidelity" implies that the Grange Meeting is a safe place, and

WHEREAS in the Ritual for closing the Subordiante/Community Grange meeting, the Master's declaration "Let us be quiet, peaceful citizens" implies that the Grange meeting is a safe place, and

WHEREAS in the opening charge to the First Degree candidates, the Master's declaration that "the chief objective of the Grange is to build a better and higher manhood and womanhood, and to develop a mutual respect and concern through Brotherhood" implies that the Grange meeting is a safe place, and

**WHEREAS** it is recognized that some citizens have properly secured a permit to carry a visible or concealed gun on their person.

THEREFORE BE IT RESOLVED that all Grange meetings and events must, at all times, be a safe place for members and non-members to meet, gather and participate, and

**BE IT FURTHER RESOLVED** that for the safety of all Grange members and non-members attending such meetings or events, guns are not necessary on the meeting or event premises, and

**BE IT FURTHER RESOLVED** that only authorized law enforcement officials will be allowed to carry a permitted visible or concealed gun at or on Grange meetings or event premises, and

**BE IT FURTHER RESOLVED** that any person carrying a gun on their person (other than authorized law enforcement officials required to carry a visible or concealed gun) must not bring it on to the Grange meeting or event premises, but either leave the gun at home or secured and locked in the glove box of their vehicle before coming on the premises of a Grange meeting or event, and

**BE IT FURTHER RESOLVED** that guns have no place or use in a Grange meeting or event and therefore all Grange meetings and event spaces are gun-free at all times, and

**BE IT FINALLY RESOLVED** that this resolution be sent to the 2019 National Grange Session for their consideration and approval. SOURCE: Cannon Grange No. 152

#### 6) RE: DIGITAL COUPONS

WHEREAS many businesses are issuing digital coupons, and

WHEREAS many people, especially senior citizens, are not literate in technology, nor have access to the required technology in order to use digital coupons.

THEREFORE BE IT RESOLVED all digital coupons issued by any business should be automatically connected to the customer courtesy card, and

**BE IT FURTHER RESOLVED** Connecticut State Grange Executive Committee urge our State Legislators to consider creating a bill to address this situation.

### 7) RE: OPPOSING TOLLS IN CONNECTICUT

WHEREAS the Governor and many members of the State Legislature have signaled support for the placement of tolls on Connecticut's major roadways, and

WHEREAS many of the residents of Sterling and Voluntown use these roadways each day for work, family obligations, and pleasure and spend a significant amount of time on these traffic congested roads, and

future prosperity of our state depends on the establishment and maintenance of a world class transportation infrastructure, the costs of implementation of such infrastructure ought not be largely funded by those who cannot afford to pay it, but by means and ideas meant to relieve the citizenry of that burden, and

WHEREAS the implementation of tolls will result in a significant amount of traffic on Sterling's roads as drivers attempt to avoid the cost burden, and

WHEREAS the residents of Connecticut already pay more in taxes and fees than most residents in other states around the country.

THEREFORE BE IT RESOLVED the members of Ekonk Community Grange are opposed to the imposition of tolls on its residents and urges its elected representatives in the State Legislature to oppose any measure that would impose tolls on our constituents.

#### 8) RE: FELONS SHALL NOT BE ELIGIBLE FOR STATE OFFICE IN CONNECTICUT

**WHEREAS** the spiritual health of any political entity rests upon the public's trust in the ethical integrity of its government, and

WHEREAS the government of democratic societies is drawn by election from its citizenry, and

WHEREAS the People of a democratic society, by common consent, may impose such requirements and restrictions on eligibility for election to public office as they see fit to ensure that eligible persons shall maintain or advance the public trust in government, and

WHEREAS it is not possible to know with absolute certainty any individual person's integrity; but the best gauge so far known to estimate their integrity is their known history of conduct; and

**WHEREAS** innumerable examples exist of persons who committed past transgressions in the public trust and may or may not have intended better in the future, yet committed further transgressions when again so entrusted, and

WHEREAS the potential injury to the body politic from such transgressions transcends economic, material, or other immediate damage, but may extend to enduring erosion of public trust in all government, to the spiritual detriment of all citizens.

**THEREFORE BE IT RESOLVED** that the policy and law of the State of Connecticut shall permanently forbid eligibility for any elective office to any person found guilty in any court in the United States of committing a felonious breach of public trust while holding any public office, but such persons shall not be otherwise be barred from public employment.

#### 9) RE: PAYMENT FOR DELEGATES

**WHEREAS** Delegates to State Session are no longer reimbursed for mileage to the Session, and

WHEREAS Delegates are no longer given a stipend for attending each day's attendance, and

**WHEREAS** Delegates do not have an incentive to stay beyond the opening roll call of Granges, and

WHEREAS by the final day of the Session, barely more than a quorum is left to vote on resolutions to be accepted or rejected, and

**WHEREAS** some of the last resolutions could directly affect or change State Grange policy.

THEREFORE BE IT RESOLVED that the Executive Committee of the Connecticut State Grange determine one fair amount to be provided to the delegates for mileage traveled and sessions attended, and payment of this amount not be given until the end of the final day of the State Session, and

**BE IT FURTHER RESOLVED** that failure to attend the full session negates the payment, and



## **Cranberry-Apple Sweet Potatoes**

One of the staples in fall cooking is apples. Midwest Living has an easy recipe for Cranberry-Apple Sweet Potatoes that is perfect to make for your next Grange Potluck - or even for the upcoming holidays!

#### **INGREDIENTS:**

- 1-21 ounce can apple pie filling
- 1-40 ounce can cut sweet potatoes, drained and cut into chunks
- 3/4 cup whole cranberry sauce
- 2 tablespoons apricot preserves
- 2 tablespoons orange marmalade
- 1/4 cup chopped pecans, toasted (optional)

#### DIRECTIONS:

Spread pie filling in an 8x8x2-inch baking dish (2-quart square). Arrange sweet potatoes over pie filling. In a small bowl, stir together the cranberry sauce, apricot preserves and orange marmalade. Spoon over sweet potatoes.

Bake, covered, in a 350 degree F oven for 25 to 30 minutes or until heated through. If you like, sprinkle with chopped pecans. Makes 6 to 8 side-dish servings

I did not send out order forms this year as all Granges that received them last year will receive the same order this year.

State Session is rapidly approaching and with it deadlines! Please send in your delegate cards as soon as your Grange decides who will represent you at State Session. Registrations are due to me by October 1. Please don't pocrastinate. Get them in early.

He has told you, O man, what is good; and what does the LORD require of you but to do justice, and to love kindness, and to walk humbly with your God? Micah 6:8

If one remembers that loving God and loving your neighbor as yourself are the two great commandments, then it follows naturally that seeking Justice is a corollary to them. In the above quote the Hebrew word *Mishpat* is translated as Justice. Another word for Justice in Hebrew is *Tzedakah*. Sometimes both are used in the same sentence, as in Deuteronomy 32:

> his work is perfect, for all his ways are justice. A God of faithfulness and without iniquity, just and upright is he.

In the above "just" is *Tzadiqh*, an adjectival form of *Tzedakah*.

Mishpat normally refers to legal justice, making sure that everyone gets a fair shake, that the workers are justly rewarded for their labor, that no punishment is



more severe than the offense, that property is not taken without due process and just compensation, that weights and measures are true. Tzedekah goes further, and requires that justice must be tempered by compassion. Once could also say it means, "doing the right thing."

Tim Keller, in an August 2012 article in Relevant Magazine explained the difference thusly:

These two words roughly correspond to what some have called "primary" and "rectifying *justice.*" Rectifying justice is mishpat. It means punishing wrongdoers and caring for the victims of unjust treatment. Primary justice, or tzadegah, is behavior that, if it was prevalent in the world, would render rectifying justice unnecessary, because everyone would be living in right relationship to everyone else. Therefore, though tzadeqah is primarily about being in a right relationship with God, the righteous life that results is profoundly social.

Both kinds of justice are necessary if we are to make a more perfect world. The prophet Amos says: "but let justice roll down like waters and righteousness like an ever-flowing stream." And in Matthew we hear Jesus say: "Woe to you, scribes and Pharisees, hypocrites! For you tithe mint and dill and cumin, and have neglected the weightier matters of the law: justice and mercy and faithfulness. These you ought to have done, without neglecting the others."

Finally, remember the Golden Rule: Do unto others what you would have them do unto you, and do not do unto others what you would not have them do unto you.
