THEREFORE BE IT RESOLVED that the Connecticut State Grange urge our Legislators to develop a plan to increase the number of bottle and can redemption centers in Connecticut to aid in the recycling of bottles and cans to help keep our state clean, and

BE IT FURTHER RESOLVED that further investigation go into all inscription codes so that all deposit bottle and cans will be accepted by the redemption centers.

WHEREAS there are many members who have put their personal and professional lives on hold for the good of Connecticut State Grange and are deserving of recognition, and



Garlic Green Beans



Olive oil, garlic, and salt are some of the best flavor enhancers for vegetables, and this trifecta stuns again with this garlic green beans recipe. Using only one pot, this simple vegetable side dish is made even easier if you grab a bag of pre-trimmed green beans from the grocery store. For busy holiday prep, blanch and chill the green beans a day in advance. When you're ready to serve, cook the garlic and stir in the green beans. It might take an extra minute or two for the green beans to heat through, but you'll have an easy Thanksgiving side dish for your menu in no time!

Green beans are full of vitamins and minerals and can certainly be very good for you! For this recipe, the green beans are simply blanched in boiling, salted water—adding no additional fat or calories. If a low fat or low calorie recipe is a priority, this recipe will work just as well if you cut the olive oil and butter in half. Use 1 tablespoon of each, for a healthier (yet still very flavorful) version.

Ingredients:

- 1-1/2 lb. fresh green beans
- Kosher salt, to taste
- 2 tbsp. olive oil
- 3 cloves garlic, chopped
- $2 \ {\rm tbsp.}$ salted butter
- Ground black pepper to taste

Directions:

1) Trim the stem end from the

green beans.

2) Heat a large pot of water over high heat until boiling. Season generously with salt. Add the green beans and cook for 3 to 5 minutes, until tender, yet still crisp. Drain and rinse under cold water to cool.

3) Return the pot to medium heat. Add the olive oil and garlic. Cook for 1 minute, until fragrant. Add the beans to the pot and stir gently to combine. Add the butter to melt and salt and pepper to taste. Serve immediately.







The oak tree in front of Wallingford Grange Hall is known as a Constitution Oak as it was planted in commemoration of the Connecticut Constitutional Convention of 1901 by Simsbury Delegate Joseph L. Bartlett.

For the nature enthusiasts: native pin oaks (Quercus palustris) produces one of the smallest acorns of the native oaks in Connecticut. Pin Oaks are commonly used in landscaping because they don't have a tap root so they are easier to ball and burlap for transporting and planting. Wildlife including wood ducks feed on their acorns . 

Striving to be Saints



by the Roman Catholic Church as deserving canonization, after a long process. Rather, I mean the much larger body of people who love God, and prioritize serving God and his people over their own selfish desires. In essence, they strive to follow the two great commandments: "you shall love the Lord your God with all your heart and all your mind, and all your soul" and "you shall love your neighbor as yourself".

The Apostle Paul begins his letter to the young church at Corinth by saying that they are "called to be saints". And the letter to the Romans begins: "To all who are in Rome, beloved of God, called to be saints". In Exodus we find God instructing Moses to tell the people: "Now then, if you will obey My voice and keep My agreement, you will belong to Me from among all nations. You will be to Me a nation of religious leaders, a holy nation."

To me the lesson is clear: none of us can make ourselves saints, but we are all called to be saints, and we become [lowercase] saints by answering God's call by loving God, loving our fellow human beings, and striving to follow God's commands.

In Judaism, Christianity, and Islam there is a concept of people who strive to be holy, and who are sometimes referred to as "saints". In Hebrew the term translated as "saints" is *qaddis*, which can also be translated as "holy ones". The Greek word used in the New Testament is "hagiosis", which also translates as "holy ones". In classical Arabic the word is *alqidsan*, best translated as "friends of Allah", or *walia tuqi*, translated as "holy one".

What is a "saint"? Some will try to divide people into "saints" and "sinners", but we all are sinners, even the holiest of saints. Let's first recognize that I am not talking about "Saints", those recognized
